Highway measures and environmental improvements along Beaufort Road and the southerly section of Wallasey Bridge Road.

The proposal includes the introduction of:

- a 3.5 metre wide shared use pedestrian/cycleway along the north side of Beaufort Road and along the east side of Wallasey Bridge Road, linking into the ped/cycle improvements at Bidston Moss.
- a zebra crossing on Beaufort Road which will provide connectivity to the new cycle lane that is being installed as part of the housing development proposal on Illchester Road
- landscaping along the length of the scheme that consider site conditions and designed to ensure that planting thrives in the future

Disability/Age/ All	Positive The creation of the shared path along Beaufort Road and Wallasey Bridge Road will connect to existing routes and create an uninterrupted route from Bidston to Birkenhead. By allowing cycling along this route it provides less confident cyclists, such as children or older people, a safer environment to cycle. Disability/Age/ All	Negative A shared path used by both pedestrians and cyclist can create the potential for conflict and can have a negative impact on disabled people and visually impaired, who may choose to avoid the shared space. Older members of the community and families may also choose not to use the path due to concerns of the presence of fast-moving cyclists.	We would have liked to introduce a segregated path as part of this scheme, but there is a masterplan for the Wirral Waters area and as part of that additional work is proposed that will create a segregated cycle path on Beaufort Road. Disability/Age/ All	Positive The project will create a segregated Tiger crossing point on Beaufort Road that currently has no pedestrian crossing facilities. This will have a positive impact for pedestrians and cyclist who wish to cross Beaufort Road when using the new footpath.	The operation of this crossing will be closely monitored. Disability/Age/ All	Negative Disabled groups, the older community and families may wish for a signal controlled crossing point with audible or tactile alert of when to cross safety. Disability/Age/ All	Negative There are a number of vehicular accesses along the route of the new footway. These accesses serve MEA Park which is the industrial/manufacturing/commercial hub of the Wirral Waters Development. As a result, although traffic movements are not expected to be high, there will be larger vehicles using these accesses. This could cause road safety concerns for all users of the shared path.	The design of the access points helps reduce speeds of vehicles entering and exiting. The design will give peds and cyclists priority over motor vehicles at these points. Effectiveness of the various elements of the scheme to be monitored via user feedback and site observations. Road Safety Audit Stages 3 (on completion of the scheme) and Road Safety Audit Stage 4 (after 1 years of the project being in place) will be carried out.

Any resulting actions will be monitored by the Project Board, which has been established to deliver this scheme. The Project Board will provide the necessary ownership, governance and strategic direction and ensure that where possible all issues in regards with inequality are rectified in line with the project objectives, outputs and outcomes within agreed timescales.

The project governance is comprised of representatives from Wirral Council, Liverpool City Region Combined Authority, Peel Group and appointed consultants.
