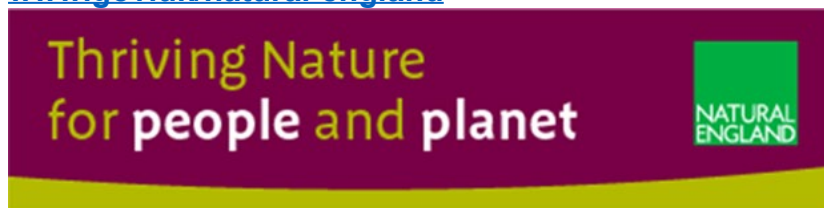

This email is to inform you about the next stage in Wirral Council's Local Plan process.

Following examination hearings undertaken between April and November 2023,

the Planning Inspectors appointed by the Secretary of State have identified the Main Modifications that are considered necessary to make the Wirral Local Plan sound and/or legally compliant. They are put forward without prejudice to the Inspectors final conclusions on the Local Plan, which will take account of all the representations submitted. The Council is now inviting comments on the Main Modifications.

Consultation will take place for a period of 6 weeks commencing at 10am on Wednesday 25 September 2024 and **the deadline for comments to be submitted on the Main Modifications is 5pm on Friday 8 November 2024.** Comments received after this deadline will not be accepted.

A notice setting out where the consultation documents can be inspected and how comments can be submitted is attached.
