As part of the consultation exercise for this scheme letters were delivered to local residents in the vicinity of the scheme, informing them of the proposals. In addition, consultation has been undertaken with Party Spokespersons, Ward Members, Active Travel Forum,

Emergency Services, Freight Transport Association, Road Haulage Association, and Merseytravel. Notices were also posted on site and with local press. The consultation exercise was undertaken between 30th September 2020 and 30th October 2020. The residents were then consulted again in February 2021 regarding a change in the proposal in order to reduce the operational hours to 10am – 5pm daily, from 8am to 6pm daily, which was originally proposed.
